

Immunity Agreement

This document is legally binding and enforceable as of the date of execution.

Parties Involved:

Disclosing Party: _____ (hereinafter referred to as “_____”).

Receiving Party: Pee Industries INC., represented by Mike Ehrmantraut, Head of the Pee Intelligence Agency (hereinafter referred to as “**Pee Industries**”).

Purpose: This Immunity Agreement (hereinafter referred to as the “**Agreement**”) is entered into by the Parties for the purpose of ensuring the complete and truthful disclosure of information concerning the operations and activities of the illegal Schwago-Hungarian Party.

1. Definitions

- 1.1. **Confidential Information:** All documents, chat logs, communications, or any material related to the operations of the illegal Schwago-Hungarian Party and its fugitive founder, Lukács Gyula.
- 1.2. **Immunity:** Legal protection granted by Pee Industries to _____, ensuring they will not be prosecuted for crimes directly related to the disclosed information, contingent upon compliance with this Agreement.

2. Obligations of _____

- 2.1. _____ agrees to disclose all Confidential Information in his possession or control that is accurate to the best of his knowledge.
- 2.2. _____ warrants that they have not and will not withhold, falsify, or alter any evidence related to the Schwago-Hungarian Party.

- 2.3. _____ identity shall be redacted from all public or legal records resulting from this Agreement, ensuring his complete anonymity in compliance with Pee Industries' prior commitment.

3. Obligations of Pee Industries

- 3.1. Pee Industries agrees not to prosecute _____ for any crimes disclosed under this Agreement, provided that:
- The disclosed information is truthful, complete, and provided in good faith.
 - _____ does not withhold any relevant evidence or engage in further criminal activity.
- 3.2. Pee Industries agrees to redact _____ name (_____) from any documentation presented in court or made available to the public.
- 3.3. Pee Industries agrees to redact any information disclosed to the public that might suggest the involvement of _____.

4. Consequences of Breach

- 4.1. If _____ is found to have knowingly withheld, falsified, or altered evidence, Pee Industries reserves the right to:
- Revoke the Immunity granted under this Agreement.
 - Initiate prosecution against _____ to the fullest extent of the law.
- 4.2. If Pee Industries fails to honor its obligations regarding immunity or redaction, _____ may pursue remedies under applicable laws.

5. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of ŠFC, especially the ŠFC Constitution.
